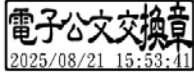

一、說明 Introduction

本計畫(原人才循環交流推動計畫，Talent Circulation Alliance Program)旨在培育具備數位專業技能與國際競爭力的人才，並提升其在全球市場的職場競爭力。本計畫提供完善的學習資源與實務操作機會，讓研習學員在數位創新領域建立扎實基礎，並能應用所學於未來職涯發展。

本計畫課程涵蓋三大領域：人工智慧、資料科學、數位行銷。研習學員將透過 TCA 網路學院課程與領域專題工作坊，學習最新數位科技趨勢，並進行專題實作與成果發表，將理論轉化為實務成果，並經由產業業師分享、企業參訪活動等，協助研習學員與業界建立連結，拓展職涯機會。

The "Talent Circulation Alliance Program" aims to cultivate individuals equipped with digital expertise and global competitiveness, enhancing their employability in the international job market. The Program offers comprehensive learning resources and hands-on training opportunities, enabling participants to build a solid foundation in digital innovation and apply their knowledge toward future career development

The Program covers three major domains: Artificial Intelligence, Data Science, and Digital Marketing. Participants will engage in online courses through the TCA Academy and attend topic-specific workshops to learn about the latest trends in digital technologies. Through project-based learning and final project presentations, they will transform theoretical knowledge into practical achievements. In addition, the Program facilitates connections with industry professionals through expert sharing sessions and corporate visits, thereby expanding participants' career prospects and industry network.

本申請須知之名詞釋義如下 Definition of Terms：

The terms used in these application guidelines are defined as follows:

(一) 數位創新人才增能培育計畫：由數位發展部數位產業署推動數位創新人才增能之計畫，透過數位專業培訓課程與人才鏈結機制，培育具備數位應用能力的專業人才，提升其國際競爭力，並促進國際人才交流。

1. Digital Innovation Talent Enhancement Program: A program initiated by the Administration for Digital Industries, Ministry of Digital Affairs, to cultivate professionals with digital application skills, enhance their global competitiveness, and promote international talent exchange through professional training and talent-matching mechanisms.

(二) 研習學員：申請參與本計畫之學員。

2. Program Participant: An applicant who seeks to participate in the Program.

二、研習期間 Program Period

研習期程：自2025年9月至2025年11月止，期間內須完成另外四門TCA 網路學院課程、領域專題工作坊及成果專題發表活動等，並繳交TCA 網路學院四門完課證明、專題成果報告書與個人心得。

Training Period: From September to November 2025, participants are required to complete four additional courses from the TCA Academy, attend topic-specific workshops, and participate in a final project presentation. They must also submit certificates of completion for the four courses, a project report, and a personal reflection essay.

三、研習學員申請資格 Trainee Eligibility

(一) 學校資格 Eligibility for School as Recommender

Applicants must be students enrolled in universities or colleges in Taiwan (regardless of major) during the first semester of the 2025 academic year, including graduate students and recent graduates. Eligible applicants include:

- (1) 四年制大學、科技大學、技術學院三年級（含）以上在學生，但不包含在職專班學生。

Students currently in their third year or above in a four-year university, university of science and technology, or technical college (excluding students enrolled in executive programs).

- (2) 二年制大學、科技大學、技術學院一年級（含）以上在學生，但不包含在職專班學生。

Students currently in their first year or above in a two-year university, university of science and technology, or technical college (excluding students enrolled in executive programs).

- (3) 大學、科技大學、技術學院碩士一年級（含）以上在學生，但不包含在職專班學生。

Students currently in their first year or above of a master's program in a university, university of science and technology, or technical college (excluding students enrolled in executive programs).

(二) 研習學員申請資格 Eligibility for Student Applicant

- 1. 申請參與本計畫之研習學員應具備下列資格：

Applicants who wish to participate in this Program must meet the following eligibility requirements:

- 2. 申請人須具有中華民國國籍或為在臺外籍生（不含陸港澳）。

Applicants must hold Republic of China (Taiwan) nationality or be international students currently studying in Taiwan (excluding students from Mainland China, Hong Kong, and Macau).

經錄取之研習生須於 2025 年 9 月 1 日至 11 月 30 日持有有效工作許可文件。工作許可申請方式依各校規定辦理，請洽各校相關學務窗口。

It is required that admitted trainees hold a valid work permit from September 1 to November 30, 2025. The work permit application process shall be carried out in accordance with the regulations of each university. Please contact the relevant student affairs office at your university for details.

本計畫不限定申請人之學科背景，歡迎來自不同領域且對數位科技、創新應用與國際交流有興趣之學生踴躍參與。惟名額有限，將優先錄取外籍生為原則。

There are no restrictions on applicants' academic backgrounds; students from diverse disciplines who are interested in digital technology, innovative applications, and international exchange are encouraged to apply. Due to limited openings, international students will be given priority consideration.

四、申請方式 Application

六、研習學員配合事項 Cooperation Requirements for Trainees

研習學員錄取後，須依以下規定完成研習計畫相關配合事項（一）至（五），以確保順利結訓並獲得結業證書及完訓獎勵，若未達成任一項目，將無法領取結業證書及完訓獎勵。

Upon admission, trainees must comply with the following requirements (1) through (5) to successfully complete the training program, obtain the certificate of completion, and receive the training subsidy. Failure to meet any of these requirements will result in ineligibility for both the certificate and the training subsidy.

- （一）繳交切結書並確認錄取意願 Submission of Affidavit Letter and Confirmation of Acceptance
- （二）參與領域專題工作坊及專題發表 Participation in Topic-specific Workshops and Final Presentation

Upon completion of items (1) through (5) as specified above, participants will be granted a completion incentive of NT\$8,000.

（一）繳交切結書並確認錄取意願 Submission of Affidavit Letter and Confirmation of Acceptance

1. 研習學員須簽署並繳交《研習學員知悉配合事項切結書》（附件一），以確認錄取意願。

Admitted trainees must sign and submit the “Trainee Acknowledgment and Commitment Agreement” (Appendix 1) to confirm their acceptance.

2. 完成切結書後，研習學員須加入計畫社群，以獲取最新課程與活動資訊，並確保與計畫辦公室保持即時聯繫。

Upon submission of the letter, trainees must join the program's LINE group to receive course updates, event announcements, and maintain real-time communication with the Program Office.

(二) 參與領域專題工作坊及專題發表 Participation in Topic-specific Workshops and Final Presentation

1. 研習學員須參與本計畫規劃24小時的領域專題工作坊，並完成專題製作與成果發表。

Trainees are required to attend a 24-hour topic-specific workshop organized by the program and complete a group project along with a final presentation.

2. 領域專題工作坊包括三大研習領域，研習學員須擇一參訓：

The workshop includes three major domains. Each trainee must select one of the following:

- (1) 人工智慧：如機器/深度學習、影像辨識、語意分析、AI 相關應用等。

Artificial Intelligence: Topics may include machine/deep learning, image recognition, semantic analysis, and AI-related applications.

- (2) 資料科學：如資料處理、資料分析、資料視覺化、網路爬蟲等。

Data Science: Topics may include data processing, data analysis, data visualization, and web crawling.

- (3) 數位行銷：如電子商務、跨境電商、網路行銷、社群行銷、MarTech 等。

Digital Marketing: Topics may include e-commerce, cross-border e-commerce, online marketing, social media marketing, and MarTech.

※本計畫保留調整學生領域安排之權利。若特定領域因報名人數不足無法開課或某領域報名人數過多，計畫辦公室將依研習學員志願序酌予調整，以確保課程順利進行。

※The Program Office reserves the right to adjust trainees' domain assignments based on registration numbers. If a specific domain has insufficient enrollment or is overbooked, assignments may be adjusted based on trainees' preferences to ensure smooth program operation.

3. 採全程實體授課，預計於9/20至11/2舉辦課程，並安排於週末。

The workshops will be held entirely in person on weekends, from September 20 to November 2.

4. 須配合計畫辦公室管理與考評制度，如出缺勤時數、專題發表及填寫滿意度問卷。

Trainees must comply with all program management and evaluation policies, including attendance tracking, project presentation, and satisfaction surveys.

(三) 參與企業參訪活動 Participation in Corporate Visits

1. 本計畫規劃安排人工智慧、資料科學及行銷科技等領域之典範企業參訪活動，結合產業鏈結與前瞻應用如全球科技領導品牌及智慧製造、雲端解決方案業者等，協助學員至企業場域深入了解產業趨勢與技術發展應用。

The program will arrange corporate visits to exemplary companies in the fields of artificial intelligence, data science, and marketing technology. These visits will integrate industry networking with advanced applications, such as leading global technology brands, smart manufacturing, and cloud solution providers, enabling trainees to gain in-depth understanding of industry trends and the application of emerging technologies on-site.

企業參訪活動排定於10月份舉辦，實際日期及場次另行通知為主，學員需依通知至少參加一場企業參訪活動。

The corporate visits are scheduled for October. The actual dates and sessions will be announced, and trainees must attend at least one corporate visit as notified.

(四) 繳交另外四門 TCA 網路學院課程完課證明 Submission of Certificates of Completion for Four Additional TCA Academy Courses

研習學員須完成另外四門 TCA 網路學院課程，並繳交 TCA 網路學院四門完課證明。

Participants must complete four additional courses from the TCA Academy and submit the certificates of completion.

(五) 繳交專題成果報告書與個人心得 Submission of Project Report and Personal Reflection Essay

1. 研習學員團隊須共同完成並繳交專題成果報告書與個人心得。

Each team must jointly submit a project outcome report, and each trainee must submit a personal reflection essay.

2. 專題成果報告書與個人心得繳交期限為課程結束後五個工作日內。

The project outcome report and personal reflection essay must be submitted within five working days after the course concludes.

(六) 凡完成上述(一)至(五)者，若為在臺外籍生需另繳交工作證明文件後，予以核發完訓獎勵新台幣捌仟元整。

Participants who have completed items (1) through (5) above, and who are international students in Taiwan, shall be granted a training completion reward of NT\$8,000 upon submission of the required work permit documentation.

※本計畫課程與專題發表皆為全英文授課，工作坊、報告撰寫及專題發表將以英語為主要語言，請研習學員確認具備基本英文聽說讀寫能力，並使用英文進行課程學習與專題發表。

※All workshops, reports, and presentations will be conducted entirely in English. Trainees should ensure they have a basic command of English in listening, speaking, reading, and writing to effectively participate in the program.

七、研習終止作業 Termination and Withdrawal

研習學員須遵守本計畫規範，如有下列情形，將依規定終止研習資格：

Trainees are required to comply with the regulations of this program. The following circumstances may result in the termination of trainee status:

（一）研習學員違反申請規範 Violation of Application Guidelines

提供不實資料：研習學員於報名時填寫虛假或誤導性資訊，如：個人經歷、學籍證明等，經查證屬實，將立即終止研習資格，並不得再申請本計畫。

Submission of False Information: If a trainee is found to have provided false or misleading information during the application process (e.g., academic credentials, personal history), their trainee status will be immediately revoked, and they will be disqualified from applying to the program in the future.

（二）未能配合計畫規範 Failure to Comply with Program Requirements

1. 研習學員無法依規定參與領域專題工作坊（含專題發表），如：未達 80% 出席率或無法完成專題發表與繳交個人心得者，應主動向計畫辦公室說明原因，並提出研習終止申請。

Trainees who fail to participate in the topic-specific workshops and project presentations as required—such as having less than 80% attendance, not completing the final presentation, or failing to submit a personal reflection essay—must proactively notify the Program Office and apply for early termination.

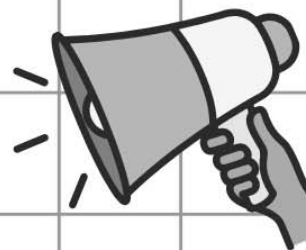

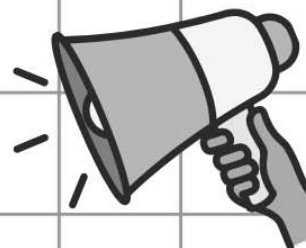
